

### Morningside Heights Historic District Phase II Survey:

Thank you to the more than 300 neighbors who recently completed our online survey on expanding Historic District protections and other quality of life issues in our community. The overwhelming majority of those who participated support implementing landmark status for additional areas of Morningside Heights (83%) and for McGiffert Hall (83%). Have you signed our <u>Phase II Historic District</u> and <u>McGiffert Hall</u> Petitions? If not, please do so and share these links with neighbors. Momentum to protect our neighborhood is growing.

Though we've faced a wide variety of challenges during the last 18 months, the work to limit further overdevelopment in Morningside Heights continues.

We have forwarded our Historic District <u>Request for Evaluation</u> to the New York City Landmarks Preservation Commission. It is now up to us to show major community support for expanding local protections.

Meanwhile, we remain concerned about the fate of McGiffert Hall and are in talks with The Riverside Church about their plans for this striking and historic building.

**Simone Weil (1909—1943):** 549 Riverside Drive

Proposed Riverside Drive—Claremont Avenue Historic District

A renowned philosopher, political activist, and mystic, Simone Weil spent most of her life developing and sharing her views on the human condition and its structures and norms. Born in Paris, during her early life she espoused strong Marxist views but turned away from them, critiquing the emergence of vast bureaucracies in the Soviet Union that harmed working people. Later in life, she experienced three profound mystical experiences that influenced her development and writing. She was a major influence on many leading thinkers, called "the only great spirit of our times" by Albert Camus.

This proposed Historic District is defined by its mix of distinguished residential buildings, which are augmented by dramatic shifts in elevation and topography. It's a beautiful part of our neighborhood whose residents have had profound local and global influences.

### From our report on the proposed Historic Districts:

"...a notable style is displayed by one of the most cohesive, intact rows of "New Law" tenement buildings of anywhere in the Heights. Located at 180-200 Claremont Ave-

nue, this entire blockfront comprising eight tenement buildings was designed Neville & Bagge in 1905, and bear all of the hallmarks of the Renaissance Revival style, incorporating Colonial Revival elements."
